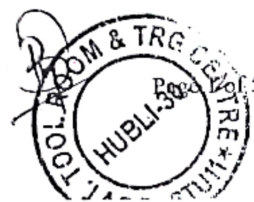

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter called as the 'MOU') is entered into on this the 10th day of – August – Two Thousand and Twenty-Four (10/08/2024), by and between

JAIN COLLEGE OF ENGINEERING, ELECTRICAL & ELECTRONICS ENGINEERING DEPARTMENT (599/2, T.S. Nagar, Hunchanhatti Road, Macche, Belagavi-590014), the First Party represented herein by its Principal, (hereinafter referred as 'First Party', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

AND

GOVERNMENT TOOL ROOM & TRAINING CENTRE, MULTI SKILL DEVELOPMENT CENTRE (Shed No. B-467 to 474, KSSIDC Industrial Estate, Gokul Road, Hubballi-580030), the Second Party, and represented herein by its Principal, (hereinafter referred to as "Second Party", company which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

- A) First Party is a Higher Educational Institution named:
 - (i) JAIN COLLEGE OF ENGINEERING, ELECTRICAL & ELECTRONICS ENGINEERING DEPARTMENT, BELAGAVI.
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.
- E) GTTC, Multi Skill Development Centre, Hubballi, the Second Party has a talented and skillful young industry work force who provide technical training to cater the requirements of industries of North Karnataka.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

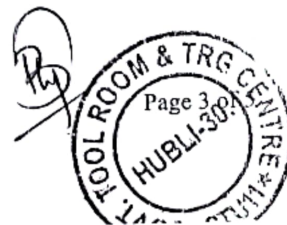


**CLAUSE 1
CO-OPERATION**

- 1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.
- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

**CLAUSE 2
SCOPE OF THE MoU**

- 2.1 The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
- 2.2 **Trainings/ Workshops/ Skill Development Programs:** Second Party to train/conduct workshops/provide skill development programs to the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready, through the above activities.
- 2.3 **Talks/ Seminars/ Guest Lectures:** Second Party to extend the necessary support to deliver talks/seminars/guest lectures to the students of the First Party on the technology trends and in house requirements.
- 2.4 **Faculty Development Programs:** Second Party to train the Faculties of First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.
- 2.5 **Placement Guidance of Trained Students:** Second Party will actively engage to help the delivery of the training and placement of students and provide necessary guidance of the First Party into internships/jobs.



- 2.6 **Site Visits:** Second party will extend the necessary support to help the first party for the site visits.
- 2.7 **Research Grants:** Second party will extend the necessary support to help the first party to apply/fetch research grants.
- 2.8 **Internships:** Second party will help to prepare, organize & conduct in-house & external internships for the first party.
- 2.9 **Student Projects:** Second Party to extend the necessary support to guide the mini projects and main projects of the students of the First Party on the technology trends.
- 2.10 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the programs on the terms specified herein.

There is no financial commitment on the part of the JAIN COLLEGE OF ENGINEERING, ELECTRICAL & ELECTRONICS ENGINEERING DEPARTMENT, the First Party to take up any program mentioned in the MOU. If there is any financial consideration, it will be dealt separately with the mutual concern of the first party and second party too.

Students will get 20% discount in course fees, provided with minimum batch quantity of 20 numbers. And fees will be directly deposited to GTTC. Fees varies every year, for present year fee structure refer Annexure-1

CLAUSE 3 INTELLECTUAL PROPERTY

- 3.1 Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4 VALIDITY

- 4.1 This Agreement will be valid for 5 YEARS (from the date of signing) and until it is expressly terminated by either Party on mutually agreed terms, during which period GTTC, Multi Skill Development Centre, Hubballi, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of Training Partner or GTTC, Multi Skill Development Centre, Hubballi, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligation.



CLAUSE 5
RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.


Second Party

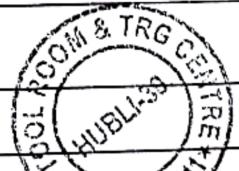


