Jain College of Engineering, an entity incorporated under the laws of India represented by its Principal. (Here in after referred as "JCE", Belagavi).

AND

SARUS AEROSPACE, Aviation and Aerospace Component Manufacturing, an entity incorporated under the laws of India represented by its founders. (Here in after referred to as "SARUS AEROSPACE").

JCE and SARUS AEROSPACE shall hereinafter be collectively referred to as "**Parties**" and individually as "**Party**"

WHEREAS

A. JCE, Belagavi is specialized in providing value-added, holistic engineering education to students at affordable costs, in a conducive academic ambiance, leading to personality development and intellectual growth.

1. Areas of Cooperation:

This MoU addresses mutual cooperation in the following areas:

- (A) Drone Technology Training
- (B) Support in Research and Development and
- (C) Advisory/committee role in academics

JCE, Belagavi Commitment

- Sarus Aerospace Pvt Ltd, will be supporting JCE to establish a state-of-the-art facility with all the required technological requirements at the institution that engages faculty and students of the institute in research, development, and training programs.
- DGCA Approved drone pilot course shall be provided for department faculties and students at the discounted price for minimum of 10 individuals in a batch as per DGCA
- Drone Engineering Course shall be offered by Sarus RPTO Pvt Ltd in affiliation with JCE for interested engineers who will be certified and ready for the industry.
- Drone Technician Course shall be offered by Sarus RPTO Pvt Ltd in affiliation with JCE for interested individuals as the industry requires a huge number of technicians who are trained and certified.

- JCE will approach SARUS AEROSPACE for internship programs as per the VTU / College customized requirement.
- JCE will be supporting the college faculty and students on the drone development for the external funding.
- Supporting innovative proposals and ideas from students in terms of functions and facilities
- JCE will provide inputs to enhance the curriculum of UAV with institutions faculty.
- JCE, will provide drone training for faculty at and above Assistant Professor grade with free of cost for two participants after completing a training of at least 20 students

B.

C. The Parties wish to co-operate with each other as per the terms and conditions enumerated in this MoU.

NOW THEREFORE THE PARTIES SET FORTH THEIR PRELIMINARY UNDERSTANDING AS FOLLOWS:

1. Scope

1.1 The scope of this MoU is to provide a framework of reference to build a strong and ongoing relationship between **JCE** and **SARUS AEROSPACE** in various areas of mutual interest and benefit.

1.2 The primary goals are:

- **Guest Talks:** Faculty Development / Certification Programs are to be conducted in the **JCE** Campus or Online for the students faculty members of the college
- **Conducting Webinars & Events:** Webinars/ Events are conducted in the above-mentioned fields for the benefit of the Students from College
- **Projects:** An opportunity, depending on availability, to selected students to get in to small or part of project with hands on to uplift the knowledge of the budding engineering students.

- **Industry Visit:** Industry visits opportunity to understand the work culture in terms of industry exposures.
- **Internships:** Extend internship opportunity to Engineering & Diploma students in the field domains like Drone systems, Artificial Intelligence, IOT, Data Science, Robotics and Product Services
- **Placements:** The recruitment opportunity for the students as per your HR/Recruitment policy, depending on requirement.

2. JCE, Belagavi and SARUS AEROSPACE establish a “Core Consulting Team”. Both the Parties shall ensure that the “Core Consulting Team” comprises of appropriate personnel from both parties to discuss and implement the ideas. Both sides will also have Single Point of Contact for coordinating various activities and for administration purpose.

2.1 JCE, Belagavi shall be represented by Dr. J. Shivakumar (Principal & Director JCE, Belagavi) & Dr. Anand K. Hosamani

2.2 SARUS AEROSPACE shall be represented by Mr. Sachin Bhusal / Mr. Rahul Patil.

2.3 The Parties hereby acknowledge and agree that “Core Consulting Team” will meet at least once in three months (every quarter) to ensure successful implementation of all programs mutually agreed to in the areas mentioned in this MoU. Dates are to be decided by mutual consultation.

3. **Responsibilities of JCE:**

- a. To provide necessary infrastructure for conduction of events. (Online/Offline)

4. **Responsibilities of SARUS AEROSPACE:**

- a. Provide Knowledge Sharing Sessions to Students of Institution.
- b. Provide Internship Programs to Students of Institution
- c. Provide Industrial Visits to Students of Institution

5. **Joint responsibilities of JCE, Belagavi and SARUS AEROSPACE**

JCE, Belagavi and SARUS AEROSPACE jointly agree:

- a. To closely work together to bring Workshop/Training opportunities for students. The workshops will be technically supported by SARUS AEROSPACE and JCE. The workshops will be technically supported with applicable charges by Sarus Aerospace and JCE, Belagavi.

- b. Trying to fill the gap between the industry & Academics by **SARUS AEROSPACE** and **JCE**, Belagavi..
- c. To work towards the success of projects and relationship fostering.
- d. To enter into a separate Non-Disclosure Agreement (NDA) to safeguard and protect each other's data confidentiality and other interests.
- e. Both the companies can use the logo for media & website as a mark of MOU between them.

6. Terms and Termination

6.1 This MoU shall come into effect from the date of signing and shall remain in effect for a period of 36 months. After a period of 36 months, MOU can be further extended based on mutual consent and agreement.

6.2 Either Party shall have the right to terminate this MoU by giving thirty (30) days prior written notice to the other Party.

6.3 For any commercial events under this MOU, shall be discussed with both the parties and require approval of both to conduct/host the same.

7. Confidentiality

7.1 Neither Party shall, without the prior written consent of the other Party disclose to any third party the contents of this MoU or any information obtained by either Party in performance of or in connection with this MoU. The Parties agree to take all reasonable measures to maintain the confidentiality of all Information which in no event will be less than the measures it uses to maintain the confidentiality of its own information of similar importance.

7.2 The obligations of confidentiality shall come into effect upon the signing of this MoU and shall survive even after the termination of this MoU.

8. **Entire Understanding**

This MoU contains the entire understanding of the Parties with respect to the subject matter addressed here in and supersede, replace and merge all prior understandings, promises, representations and agreements, whether written or oral, relating thereto.
